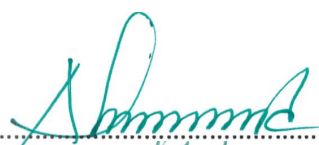
STATEMENT OF RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

REPORT OF THE INDEPENDENT AUDITORS TO THE COUNCIL MEMBERS OF YOLA NORTH LOCAL GOVERNMENT COUNCIL

We have audited the financial Statements of Yola North Local Government Council as at 31st December, 2019, set out on pages 6 to 10 which have been prepared on the basis of the accounting policies on page 11.

Council Responsibility for the Financial Statements:

The Council is responsible for the preparation and fair presentation of these Financial Statements. a. Statement of Compliance and Basis of Preparation

The financial statements have been prepared in accordance with and comply with International Public Sector Accounting Standards (IPSAS). The accounting policies have been consistently applied to all the years presented.

The financial statements have been prepared on the basis of historical cost, unless stated otherwise. The cash flow statement is prepared using the direct method. The financial statements are prepared on Cash Basis.

b. Revenue

Revenue from Federation Account Allocation Committee (FAAC), Independent Revenue, Capital Receipts and Other Revenues were recognized in the year they were actually received.

c. Recurrent Expenditure

They were considered in the financial statements in the year that payments were made.

d. Capital Expenditure

Expenditure of capital in nature were written off in the same year they were charged to the account.
